- **Communications – Cynthia Reeves**



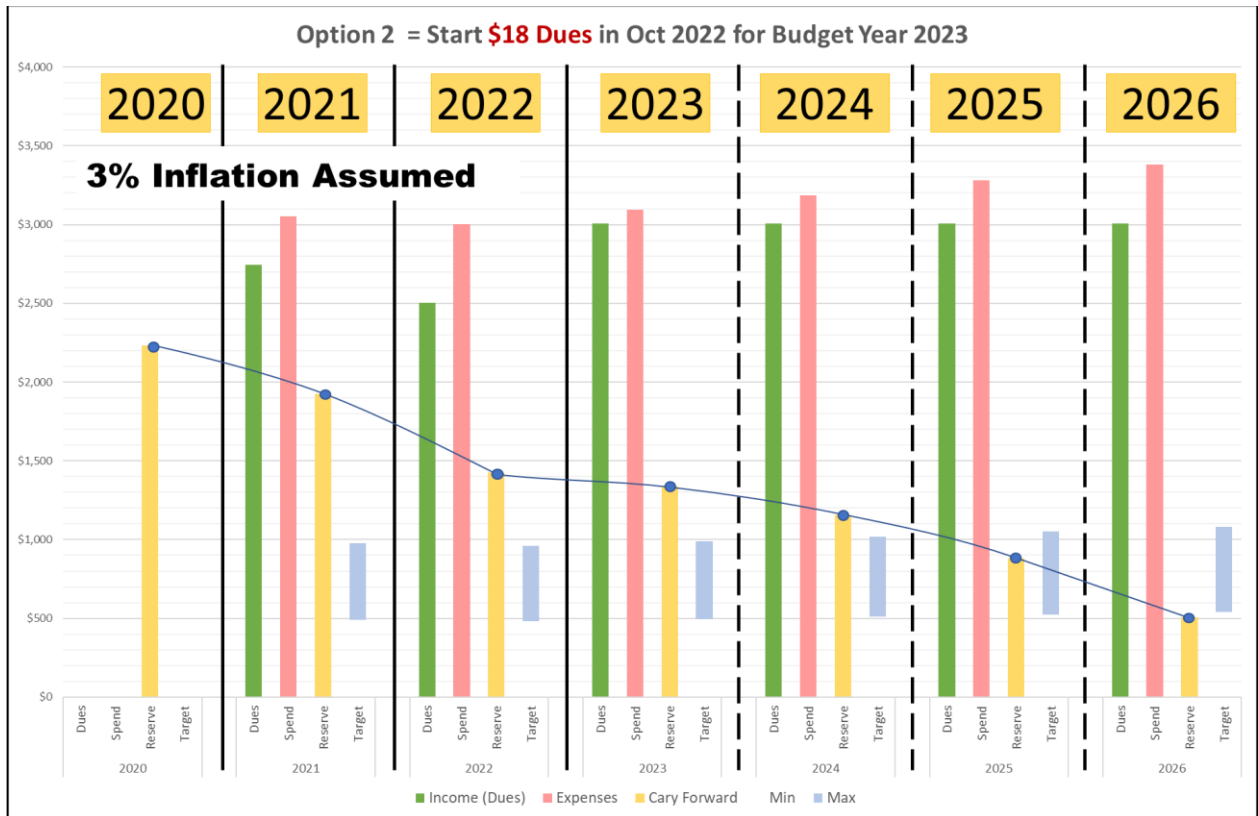
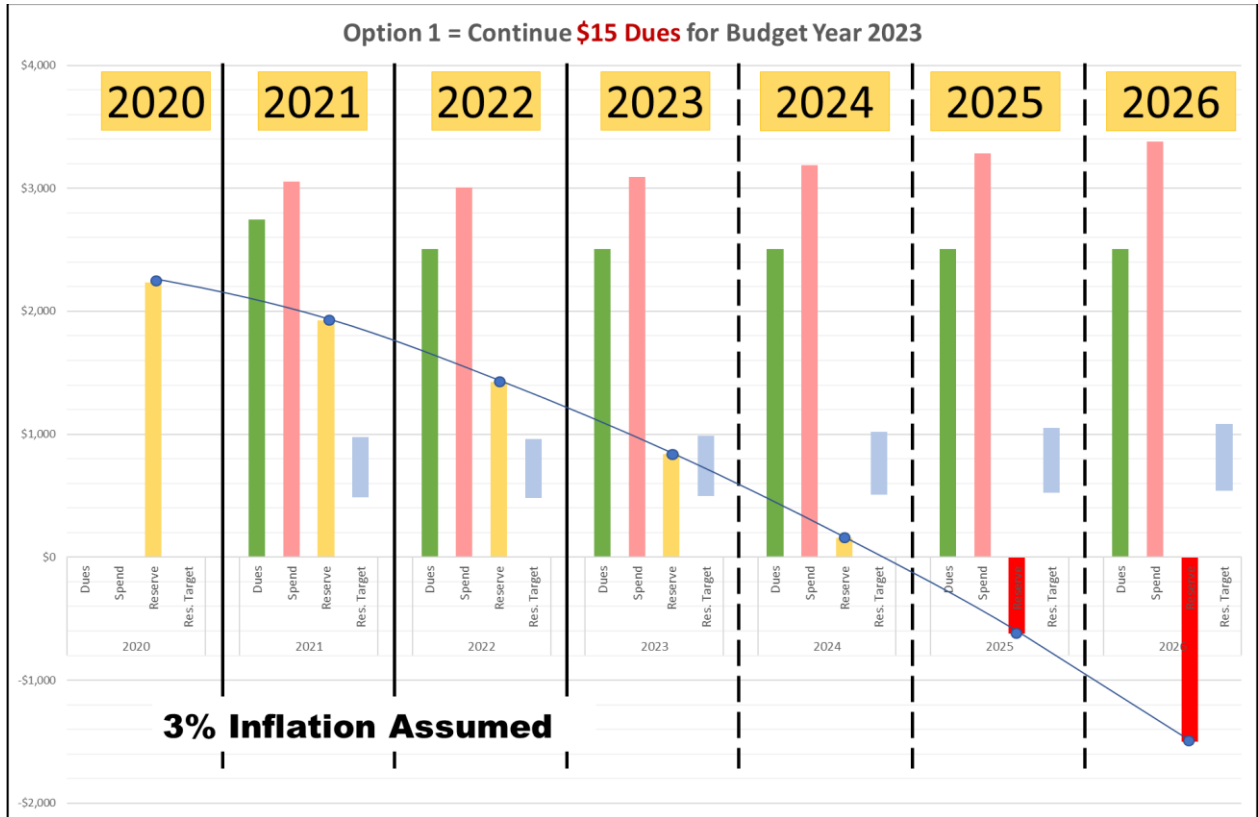
